PADA menjalankan kuasa yang diberikan oleh subseksyen 28B(1) Akta Duti Timbal Balas dan Anti-Lambakan 1993 [*Akta 504*] dan subseksyen 11(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Duti Anti-Lambakan) (Kajian Semula Dipercepat) (No.2) 2021**.

(2) Perintah ini hendaklah mula berkuat kuasa pada 17 Disember 2021.

2. Pengeunaan duti anti-lambakan di bawah Perintah Kastam (Duti Anti-Lambakan)(Kajian Semula Pentadbiran)(No. 2) 2021 [*P.U. Ltd. pengeksport gegelung keluli yang dipracat, dicat atau disalut warna dari Republik Rakyat China semasa kajian semula dipercepat sedang dijalankan dari 17 Disember 2021 hingga 15 Jun 2022.

COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993 AND CUSTOMS ACT 1967

CUSTOMS (ANTI-DUMPING DUTIES)
(EXPEDITED REVIEW) (NO. 2) ORDER 2021

IN exercise of the powers conferred by subsection 28B(1) of the Countervailing and Anti-Dumping Duties Act 1993 [Act 504] and subsection 11(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Anti-Dumping Duties) (Expedited Review) (No. 2) Order 2021**.

(2) This Order shall come into operation on 17 December 2021.

Period of expedited review

2. The anti-dumping duties imposed under the Customs (Anti-Dumping Duties) (Administrative Review) (No. 2) Order 2021 [P.U. (A) 312/2021] shall not be imposed on Shandong Ruifeng Composite Material Co. Ltd. the exporter of prepainted, painted or colour coated steel coils products from the People's Republic of China while the expedited review is being carried out from 17 December 2021 until 15 June 2022.
