- (ii) dengan menggantikan noktah di hujung subperenggan (c) dengan perkataan “; dan”; dan
- (iii) dengan memasukkan selepas subperenggan (c) subperenggan yang berikut:

“(d) margin lambakan didapati wujud melalui kegiatan lambakan oleh pengeluar atau pengeksport dari Republik Rakyat China, Republik Korea dan Republik Sosialis Viet Nam sebagaimana yang dinyatakan dalam Jadual Pertama melainkan bagi pengeluar atau pengeksport Hoa Sen Group dan Ton Dong A Corporation kerana margin lambakan bagi pengeluar atau pengeksport tersebut adalah Nil.”;

- (b) dalam perenggan 4, dengan menggantikan perkataan “Yieh Phui (China) Technomaterial Co., Ltd. dan Southern Steel Sheet Co., Ltd.” dengan perkataan “Yieh Phui (China) Technomaterial Co., Ltd., Southern Steel Sheet Co., Ltd., Hoa Sen Group dan Ton Dong A Corporation”;
- (c) dalam butiran 3 Jadual Pertama, dalam ruang “Margin Lambakan”—
- (i) berhubung dengan “Hoa Sen Group”, dengan menggantikan perkataan “16.55%” dengan perkataan “Nil”; dan
  - (ii) berhubung dengan “Ton Dong A Corporation”, dengan menggantikan perkataan “15.87%” dengan perkataan “Nil”; dan
- (d) dalam butiran 3 Jadual Kedua, masing-masing dalam ruang “Pengeluar atau Pengeksport” dan ruang “Kadar Duti [Peratusan (%) daripada Nilai Kos, Insurans dan Tambang (KIT)]”, berhubung dengan Republik Sosialis Viet Nam—
- (i) dengan memotong perkataan “Hoa Sen Group” dan perkataan “16.55%”; dan
  - (ii) dengan memotong perkataan “Ton Dong A Corporation” dan perkataan “15.87%”.

AMENDMENT OF NOTICE OF AFFIRMATIVE FINAL DETERMINATION OF AN ANTI-DUMPING DUTY INVESTIGATION WITH REGARD TO THE IMPORTS OF FLAT ROLLED PRODUCT OF NON-ALLOY STEEL PLATED OR COATED WITH ALUMINIUM AND ZINC ORIGINATING OR EXPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA, THE REPUBLIC OF KOREA AND THE SOCIALIST REPUBLIC OF VIET NAM

The Notice of Affirmative Final Determination of an Anti-Dumping Duty Investigation with regard to the Imports of Flat Rolled Product of Non-Alloy Steel Plated or Coated with Aluminium and Zinc Originating or Exported from the People's Republic of China, the Republic of Korea and the Socialist Republic of Viet Nam [*P.U. (B) 679/2020*] published on 11 December 2020 is amended—

(a) in paragraph 3—

(i) by deleting the word “and” at the end of subparagraph (b);

(ii) by substituting for the fullstop at the end of subparagraph (c) the words “; and”; and

(iii) by inserting after subparagraph (c) following subparagraph:

“(d) the dumping margin is found to exist through the dumping activities by the producers or exporters from the People's Republic of China, the Republic of Korea and the Socialist Republic of Viet Nam as specified in the First Schedule except for producers or exporters Hoa Sen Group and Ton Dong A Corporation since the dumping margin for such producers or exporters are Nil.”;

- (b) in paragraph 4, by substituting for the words “Yieh Phui (China) Technomaterial Co., Ltd. and Southern Steel Sheet Co., Ltd.” the words “Yieh Phui (China) Technomaterial Co., Ltd., Southern Steel Sheet Co., Ltd., Hoa Sen Group and Ton Dong A Corporation”;
- (c) in item 3 of the First Schedule, in the “Dumping Margin” column—
- (i) in relation to “Hoa Sen Group”, by substituting for the words “16.55%” with the word “Nil”; and
  - (ii) in relation to “Ton Dong A Corporation”, by substituting for the words “15.87%” with the word “Nil”; and
- (d) in item 3 of the Second Schedule, in the “Producer or Exporter” and “Rate of Duty [Percentage (%) of the Cost, Insurance dan Freight (CIF) Value]” column respectively, in relation to the Socialist Republic of Viet Nam—
- (i) by deleting the words “Hoa Sen Group” and the words “16.55%”; and
  - (ii) by deleting the words “Ton Dong A Corporation” and the words “15.87%”.
