(PINDAAN) 2026

PADA menjalankan kuasa yang diberikan oleh subseksyen 11(1) Akta Kastam 1967 [*Akta 235*] dibaca bersama-sama seksyen 28 Akta Duti Timbal Balas dan Anti-Lambakan 1993 [*Akta 504*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Duti Anti-Lambakan) (Kajian Semula Pentadbiran) 2025 (Pindaan) 2026**.

(2) Perintah ini berkuat kuasa bagi tempoh mulai 15 Januari 2026 hingga 22 Jun 2030.

2. Perintah Kastam (Duti Anti-Lambakan) (Kajian Semula Pentadbiran) 2025 [*P.U. (A) 192/2025*] dipinda dalam subperenggan 4(1) dengan menggantikan perkataan “Rukun Tafsiran dalam Perintah Duti Kastam 2022 [*P.U. (A) 114/2022*]” dengan perkataan “Rukun Tafsiran Am Sistem Berharmonis sebagaimana yang dinyatakan dalam perenggan 4 Perintah Duti Kastam 2025 [*P.U. (A) 384/2025*]”.

COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993

CUSTOMS (ANTI-DUMPING DUTIES) (ADMINISTRATIVE REVIEW) ORDER 2025
(AMENDMENT) ORDER 2026

IN exercise of the powers conferred by subsection 11(1) of the Customs Act 1967 [Act 235] read together with section 28 of the Countervailing and Anti-Dumping Duties Act 1993 [Act 504], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Anti-Dumping Duties) (Administrative Review) Order 2025 (Amendment) Order 2026**.

(2) This Order has effect for the period from 15 January 2026 to 22 June 2030.

Amendment of paragraph 4

2. The Customs (Anti-Dumping Duties) (Administrative Review) Order 2025 [P.U. (A) 192/2025] is amended in subparagraph 4(1) by substituting for the words “Rules of Interpretation in the Customs Duties Order 2022 [P.U. (A) 114/2022]” the words “General Rules for the Interpretation of the Harmonized System as specified in paragraph 4 of the Customs Duties Order 2025 [P.U. (A) 384/2025]”.
