PADA menjalankan kuasa yang diberikan oleh subseksyen 11(1) Akta Kastam 1967 [*Akta 235*] dibaca bersama-sama seksyen 28 Akta Duti Timbal Balas dan Anti-Lambakan 1993 [*Akta 504*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Duti Anti-Lambakan) (Kajian Semula Pentadbiran) (No. 2) 2026 (Pindaan) 2026**.

(2) Perintah ini berkuat kuasa bagi tempoh mulai 15 Januari 2026 hingga 8 Oktober 2026.

**Pindaan Jadual**

2. Perintah Kastam (Duti Anti-Lambakan) (Kajian Semula Pentadbiran) (No. 2) 2026 [*P.U. (A) 24/2026*] dipinda dalam Jadual, dalam ruang (3)–

(a) dengan memotong butiran “(b) Republik Korea” dan butir-butir yang berhubungan dengannya dalam ruang (4) dan (5); dan

(b) dengan memotong butiran “(c) Republik Sosialis Viet Nam” dan butir-butir yang berhubungan dengannya dalam ruang (4) dan (5).

COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993

CUSTOMS (ANTI-DUMPING DUTIES) (ADMINISTRATIVE REVIEW)  
(NO. 2) ORDER 2026 (AMENDMENT) ORDER 2026

IN exercise of the powers conferred by subsection 11(1) of the Customs Act 1967 [Act 235] read together with section 28 of the Countervailing and Anti-Dumping Duties Act 1993 [Act 504], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs (Anti-Dumping Duties) (Administrative Review) (No. 2) Order 2026 (Amendment) Order 2026**.

(2) This Order has effect for the period from 15 January 2026 to 8 October 2026.

**Amendment of Schedule**

2. The Customs (Anti-Dumping Duties) (Administrative Review) (No. 2) Order 2026 [P.U. (A) 24/2026] is amended in the Schedule, in column (3)—

(a) by deleting item “(b) The Republic of Korea” and the particulars relating to it in columns (4) and (5); and

(b) by deleting item “(c) The Socialist Republic of Viet Nam” and the particulars relating to it in columns (4) and (5).
